- **REMEMEBER Your invoice needs to be fully paid prior to shipping your product.**

• **YOUR INITIAL BALANCE PAYMENT IS DUE 10 days after your order is placed or at time of test pressing approval(vinyl). (if you did not pay in full initially.)** Failure to send in payment at this time will not stop your order however may cause the timely shipping of your order to be delayed.

- **PROVIDE US A UPS account number for shipping,** if you do not have one, You will be billed for this shipping upon completion of your order. You will need to make a payment immediately so we can ship your project. (This can be speeded up by providing a UPS account#, or a credit card number to charge the shipping balance you will owe.) **WE WILL NOT SHIP WITHOUT FINAL PAYMENT.**
- **TO ENSURE QUICK PROCESSING,** please provide a professionally created master audio source, and artwork ready to be processed. Any errors, or changes will delay your order.
- **SHIPPING IS NOT INCLUDED IN PROJECTED TURN TIMES.** This includes test pressings, and time required to send anything to our facilities, or shipping to you, or your final destination. Ordering of test pressings can delay your turn times. Remember that due to the nature of manufacturing, turn times can not be guaranteed.

- **REMEMBER Your invoice needs to be fully paid prior to shipping your product.**
- **If you paid a partial down payment and did not pay your balance 10 days after placing your order, you will need to pay the balance immediately.**
Recordpressing.com will usually send you a final invoice **1-3 days** prior to the date your project is ready to ship. However there may be additional charges that get added even after we ship. (we cannot always finalize invoices prior to this time)

All estimates and quotes include mastering (glass master, metal work, lacquer, DMM etc.. not pre-mastering) charges. If you do not have line items for mastering items and do not supply these items yourself, you will be billed for them on your final invoice. We do not include shipping, film, proofs, or charges for additional adjustments such as art or audio pre-flight, repeat submission charges or any additional parts or processes that are ordered on your order forms, or during the manufacturing process, or required to complete your order correctly but not placed on an initial estimate. They will be added in final invoice. Final invoice will be sent out usually within 1-3 days prior to completion of your project. We may adjust your invoice to reflect ordered services at any time. Orders require 75% of total balance when submitted and the remainder within **10 days** after initial order is placed. Additional charges may be added after the 10 day period. **We will not ship prior to current balance being paid at the time of shipment.** First time orders 100% pre-payment. Orders under one thousand dollars require full balance upon placement of order. Orders submitted from customers outside of the United States require full balance upon ordering. We accept bank wire transfers (subject to bank wire charge) checks, cashiers checks, money orders, cash, as well as other secure forms of payment. We accept VISA, MASTER CARD, DISCOVER and AMERICAN EXPRESS for final invoice payments only. Due to the variables involved in manufacturing a product from scratch exact turn times are not always be possible. **DO NOT ORDER WITHOUT AMPLE TIME FOR ANY UNFORSEEN ISSUES OR DELAYS.** We are not responsible for orders left over two months. Recordpressing.com is not responsible for inactive parts after 12 months. They may be destroyed, returned, or recycled at our discretion. Recordpressing.com reserves the right to sell off or liquidate any product in our possession to recover any outstanding balances after 60 days. All artwork must be completed to our specifications, and must be accompanied by a proof, or match print, in order to guarantee accuracy. Recordpressing.com will not be liable for printing errors if proofs are not supplied, and "printed proofs" are not ordered for approval at time of ordering. Please follow the following format and arrangement specs for the best service. Incomplete or illegible files will result in production delays, and possibly poor presentation of final product. We require that **all graphic arts be received in a recordpressing.com template. While we will do an initial file check for you, any changes after the initial check will be billed, so please follow instructions. Your turn-time does not begin until all parts are received.**

File formats

It is necessary for all files received by Recordpressing.com to be presented in a high quality file formats such as **EPS, and TIFF. GIF and JPEG formats are not acceptable.** Due to this specification, it is necessary for all files delivered to recordpressing.com to be art files saved as Adobe Illustrator, or EPS with **all text converted to outlines, and all images embedded. NOT PHOTOSHOP.** This will ensure that your artwork will be uploaded in its complete state for prepress/print production.

All files should be submitted on a CD-R or Zip Disk or sent to us via FTP or through our website (please contact us for more information). If you do send via FTP, You MUST EMAIL help@recordpressing.com to notify us or it will sit there unnoticed. WE DO NOT ACCEPT EMAILED FILES.

Colors

All used colors should be in the model **CMYK** or direct (spot) colors must correspond to the **Pantone scale (PMS). DO NOT USE RGB EVER!** All direct (spot) color must be specified within the area provided for spot colors. Files that include mixed colors, renamed Pantone colors or RGB 'new color' are not usable. Please note that due to differences in label and jacket paper stock, matching label colors to jacket colors or CD faces is difficult and we strongly suggest using spot colors to accomplish the closest match.

FILM (if required)
